**POST OF TEMPORARY ASSISTANT LECTURER  
DEPARTMENT OF COMMERCIAL LAW**

The University of Colombo will entertain applications from suitably qualified persons for the above posts up to **28<sup>th</sup> February 2025**.

**This is a Temporary position. Initially the appointment shall be for a period of 06 (six) months. The positions may be renewed for a maximum of another 18 months based on performance, and need during the period of the operation.**

**01. EDUCATIONAL QUALIFICATIONS**

**(A) Temporary Lecturer:**

(1) A Degree in **Bachelor of Laws (LL.B)** with First or Second Class (Upper Division) Honours;

**OR**

(2) A Degree in **Bachelor of Laws (LL.B)** with Second Class (Lower Division) Honours;

**OR**

(3) (a) A Degree in **Bachelor of Laws (LL.B)** without a class;

**and**

(b) (i) A Doctoral Degree in **Law** or in the relevant field

**or**

(ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

**or**

(iii) A full time Masters Degree in the relevant field of a minimum of 18 months duration with at least 60 credits\* of which not less than 15 credits\* of research by way of thesis/dissertation

*[\*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]*

- *Preference will be given to candidates who are proficient in teaching in both the selected medium and English.*
