## REPAIRING ROOF OF THE FACULTY OF LAW (WING C) - UNIVERSITY OF COLOMBO CONTRACT No. MD/MR/C/28/2018

- 1. The Chairman, Department Procurement Committee on behalf of the University of Colombo, Cumaratunga Munidasa Mw, Colombo 3 invites sealed bids from eligible and qualified bidders for **Repairing Roof of the Faculty of Law (Wing C), University of Colombo.** As described below and estimated to cost Rs.15.3 million without Taxes & Contingencies. The site is located at University of Colombo. Items under the proposed work mainly consist of renovation works including Demolition, Painting, Roof Works, Ceiling works and Electrical works. The Construction period is 90 days.
- 2. Bidding will be conducted through National Competitive Bidding.
- 3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements

- 4. Qualification requirements to qualify for contract award include:
  - a) Average annual value of work performed in last Five years shall be at least Rs. 92.0 million.
  - b) The minimum Amount of Liquid Assets or credit facilities required is Rs. 15.3 million.

- 7. Bids shall be delivered to the Chairman, Department Procurement Committee, University of Colombo to reach on or before 2.30 p.m. on 21st August 2018. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
